Non-Service Connected Pension Benefits:

There is a pension benefit available for all veterans and their surviving spouse if that claimant meets the following criteria for this need-based program.

1. The Veteran must have 90 days of service with at least one day during a wartime period.
2. The VA will determine whether you qualify for this benefit based on your income from all sources and your net worth. The Veteran must be considered totally disabled but the surviving spouse does not need to be. There are 3 levels of pension benefits, Basic, Housebound and the need for Aid and Attendance. The VA will determine your countable income after you report all your paid medical expenses to include in-home care and nursing home care.

DID YOU KNOW?



- 1) The Veterans of Foreign Wars is the oldest Veterans Service Organization, founded in 1899.
- 2) The VFW Veterans Service Program was established in 1920 and ten years later in 1930 the Veterans Administration was established.
- 3) Our mission is to assist all veterans and their dependents in getting their benefits from the Department of Veterans Affairs. There is no charge for our services.
- 4) The VFW Service Officers in Missouri were successful in obtaining 327 million dollars in VA benefits for the Veterans in the State of Missouri last year.

WHAT YOU NEED TO KNOW

ABOUT COMPENSATION:

Disability compensation is awarded for an illness or injury caused by, or gotten worse because of your active military service. Compensation is a non-taxable income from the Department of Veterans Affairs. Depending on the amount of disability you are awarded you may receive additional benefits for dependents and on the healthcare side of the VA.



10% entitles a veteran to free inpatient and outpatient care. They are also entitled to appliances such as eye glasses and hearing aids. 30% you can add your eligible dependants to your monthly compensation award. You are also entitled to travel pay for your scheduled outpatient visits.

50% all medication for all conditions at a VA facility is free of charge.

60% for on disability you meet schedular requirement for filing for individual unemployability if you are not able to work as a direct result of your service—connected disability.


70% to 100% you are entitled to the same benefit as 60% plus the veteran is entitled to free nursing home care if they apply through the VA.

100% all the benefits listed above plus education and medical benefits for eligible dependents if the veteran is permanently and totally disabled. The medical benefit is called ChampVA. It is a comprehensive health care program in which the VA shares the cost of covered health care services and supplies with eligible beneficiaries. Your spouse is entitled to some coverage for nursing home expenses. The veteran is also entitled to dental benefits.

DID YOU KNOW?: That service connection is automatically granted for any honorably discharge veteran who has Amyotrophic Lateral sclerosis (ALS). If you ever hear of someone who has or had this condition inquire whether or not they are a veteran. They or their surviving spouse can receive benefits.

The number one and two disabilities granted by the VA in the Country is hearing loss and tinnitus. If a veteran had an occupation in service that would have exposed them to hazardous noise and they feel their hearing loss and tinnitus is a result of that exposure then they should file a claim. The veteran did not have to be treated for these conditions in service.

The VA recently changed the law to make veterans who served off of the coast in Vietnam eligible for benefits based on their exposure to Agent Orange. These veterans were denied their benefits in the past and may not know of this change. There are also surviving spouse throughout the state of Missouri that are entitled to benefits and don't know it. If their spouse passed away because of a disability related to Agent Orange exposure they need to contact us immediately!
